Electronic Vote Prior to Congress

1. Introduction

This document is the fourth in a series of [guidance notes](#) prepared by the IUCN Secretariat on the motions process. It presents the process for the electronic vote of motions prior to the Congress and explains the electronic voting system, providing detailed information on how to use the different features as well as the electronic vote process.

The electronic vote on motions will take place **from 13:00 GMT/UTC on 27 August to 13:00 GMT/UTC on 10 September 2025**. The **results** will be published **by 24 September 2025** in the form of a Congress document. In addition, records of all votes of each individual IUCN Member, together with any statements in explanation of votes received before 10 September 2025 at 13:00 GMT/UTC, will be made available to all Members through the Union Portal within two weeks following the close of the electronic vote.

The electronic voting system is based on [the IUCN Statutes, Rules of Procedure of the World Conservation Congress \("Rules of Procedure"\) and Regulations](#). Please consult the [Motions page](#) of the Congress website for the latest updates.

2. The electronic vote in a nutshell

All IUCN Members in Category A, B and C eligible to vote, i.e. **which have paid their membership dues in full up to and including 2024**, are encouraged to exercise their rights by participating in the electronic vote on motions. Through the motions process,

Members define the general policy of IUCN, and greater participation among Members will confer more legitimacy upon adopted motions, which become Resolutions or Recommendations.

All motions can be accessed on the [Congress website](#). **Please refer to [Annex 1](#) of this document for a list of the ninety seven (97) motions submitted by the Motions Working Group to the electronic vote.**¹ This list also indicates whether a motion contains one or more amendments to be voted upon separately.

On **27 August 2025**, the 'Authorized vote holder' (AVH) of each IUCN Member will receive an email including a unique URL link to access the secure site. In order to vote, the AVH must click the link to access the electronic ballot and cast the votes for their organisation/institution. The AVH will be invited to cast a vote on each motion. In most cases one single question is asked per motion, namely whether the Member adopts the motion. Voting shall be expressed by **YES, NO** or **ABSTAIN** (Figure 1).

In the case that there are amendments to a motion, multiple questions will have to be answered. Amendments are alternative text options which the Motions Working Group has decided to put to the vote separately, either because there is little, if any, prospect of reaching agreement among the proponents of the various text options, or they were brought forward by IUCN Members at the very end of the online discussion. There are **nine (9) motions with amendments** submitted to the vote.

After having expressed their votes on the motions on behalf of the IUCN Member, the AVH must still officially submit their votes for them to be registered in the electronic system. This takes place at the end of the voting process.

Step-by-step overview:

1. If you are the AVH, you will receive an email on 27 August 2025 with a unique link

to the electronic voting system.

2. Click on link to enter system (no login/password is required).
3. A Transparency Agreement page will be displayed on the screen. Click “I understand” to continue to the vote.
4. The questions to be voted on will be displayed on the screen.
5. Tick a checkbox to select your vote choice (yes, no, or abstain).
6. When you have completed your ballot, you may add a written statement. To do so, please use the yellow box at the bottom of the page.
7. **Proceed to vote confirm page** to check and modify your vote if necessary.
8. To save your votes, click the ‘**Confirm and save / submit my vote**’ button.
9. The system will display a vote confirmation message, and you will receive an email confirmation in your inbox. Click on the **Click to view vote receipt** link to view the receipt online. This will show you how you voted for all the questions.

3. Frequently asked questions

How do I receive the electronic ballot?

The 'Authorized vote holder' (AVH) of every IUCN Member eligible to vote, will receive an electronic message from IUCN's secure voting system from "IUCN Members – Electronic Vote" [noreply-150527@bigpulse.com] with the subject "**IUCN Congress 2025: Electronic Vote by IUCN Members on Motions – voting initiated**" with a unique URL, which will allow them to access the electronic ballot for the IUCN Member they represent. No login or password is required to access the system.

The vote will be open from 13:00 (GMT) on [REDACTED] and will close at 13:00 (GMT) on [REDACTED]. Voting outside of these times is not possible.

By 13:00 GMT/UTC on **27 August 2025**, all Members should have received the message with the unique URL to cast their vote **sent to the email address of their AVH**. If the AVH does not receive the link, please see the "Troubleshooting" section below.

To access the electronic voting system, the AVH should click on the link to the Electronic Vote in the email sent out on **27 August 2025**. The AVH will be taken into the electronic voting system and the question to be voted on will be displayed on the screen.

The electronic ballot will identify the IUCN Member voting and will contain all motions submitted to the electronic vote (including those with amendments).

Please note that the IUCN Member's URL is unique. **If the AVH has not finished the voting process (i.e. has not answered all the questions and wishes to return to complete the vote) they should submit their votes (by clicking on the "Confirm and save / submit my vote" button) to save their selection.** The AVH may use their URL to return to the ballot to complete and resubmit their votes at any time before 13:00 (GMT) on 10 September 2025. By submitting their votes, the electronic vote platform will save their progress and responses to the motion questions on which they have already voted.

How do I vote on motions?

For each motion the AVH will be provided with the **number and title** of the motion, as well as a **link** to the text of the motion in its final version put to the electronic vote (it should have 'EVOTE' in the filename). The AVH will be asked whether they adopt that given motion.

In order to vote on a motion, including one with amendments, please follow the following instructions:

1. Once you are in the system, you will be directed to a Transparency Agreement page. You will see the name of your organisation at the top of the screen.
2. Click on the **I understand** button to be taken to the voting page.

Transparency Agreement

Consistent with the requirement under Rule of Procedure 71, the complete voting record of each IUCN Member shall be made available to all IUCN Members within two weeks following the close of the electronic ballot. IUCN Member transmits their Member's URL to a colleague from within their organization/institution or to another Member, to cast their vote.

Do I have to vote on every single motion?

No, you do not need to vote on every single motion.

At the end of the voting process, before saving and submitting all your votes, you will be able to see the motions you have not voted upon. At this stage, you may still decide to vote on any of these motions or modify your votes on other motions. To do so, please click on the **"Back to make a correction "** button.


When the motions adopted by electronic vote become effective?

Article 62^{septimo} of the Rules of Procedure provides that the motions adopted by electronic ballot prior to Congress become effective on the date the Members' Assembly takes the decision to "record" *en bloc* their adoption. This would mean that

the motions adopted by the electronic vote closing on 10 September 2025 will only become effective during the Members' Assembly.

How can I access the motion I am voting on?

In order to see the text of the motion you are voting on, please click on the link below the question. Note that it you will be taken to the relevant motions page where you can select to view the motion in one of the three official IUCN languages. Once you are on the page, select the top link to view the text of the motion. The link will contain the motion number-EVOTE-and the motion title.

How can I see the amendment(s) to a motion?

All motions with amendments are clearly identified in the ballot with an asterisk and with the addition of "with amendment ABC" in the title. In order to see the amendment(s) to a motion, just follow the link to the motion as outlined above. The amendments are presented directly in the body of the motion, in different colours.

REQUESTS that IUCN include a thematic focus and symposium on primary forests and other primary ecosystems at the next World Conservation Congress, to further raise awareness of the importance of primary ecosystems and ecosystem integrity, and the contributions of such ecosystems to addressing the climate and biodiversity crises, and their significance for and critical role of Indigenous peoples, Indigenous and traditional territories, and local communities; and

How do I vote on motions with amendments?

At Congress, the process of voting on amendments and motions takes place in multiple rounds. First, the amendments are voted upon and only thereafter the motion as possibly amended is put to the vote. In cases where there are two amendments to the same part of the motion, the chair puts to the vote first the amendment that differs most from the text of the motion that it seeks to amend. Should this first amendment pass, the second amendment is disregarded (Rule 61). However, should the first amendment not be approved, the second amendment is then put to the vote. Depending on the outcome of this vote, the Chair puts the motion as amended (or not) to the vote. Voting in such a manner is possible on site, because the outcome of each vote on the amendments is known immediately.

However, in the electronic vote prior to Congress the outcome of the vote on each question will only be known when the results of the vote are published after the closing of the voting process. **Thus, the electronic vote must provide results for all eventualities. It is important that you answer all those questions with/without amendments for a given motion, if you decide to vote on that specific motion.** However, the results of the vote on some of these questions will only be taken into account and published if the motion with amendment(s) as submitted with the preceding question(s), is not adopted.

Thus, amendments in the electronic vote are handled in a specific manner and guided by specific rules:

1. The vote is not on the amendment, but on the motion as modified by the proposed amendment. The question asked will be: "Do you adopt Motion XYZ with amendment ABC?"

2. The amendments are listed in the order of the paragraphs they refer to in the motion. Where there are amendments to the same part of a motion, the motion with the amendment most different from the text of the motion that it seeks to amend will be voted upon first.

The order in which the amendments (motions with amendments) are tabled for vote (i.e. the order in which the questions are asked) is very important. The motion with amendments will be voted before the motion without amendments. This sequencing is governed by Rule 60 for all types of amendments. In addition, Rule 61 provides specific rules for the sequencing between amendments relating to the same part of the motion. This sequencing will have an impact on whether or not the result to the subsequent question will be taken into account. Only the results of the votes which are relevant will be published.

3. For every motion with one or more amendments, the last the question asked will be; "Do you adopt Motion XYZ without amendment(s)?" The result of this vote will only be taken into account and published, if the motion was not adopted with any of the amendments proposed in the previous question(s).
4. For amendments related to the same part of a motion, the results of the vote on the motion with amendment(s) will only be taken into account and published if the motion with amendment(s) as submitted with the preceding question(s) is not adopted. For example, if there are two amendments related to the same part of a motion and the motion with the first amendment passes, the results of the vote on the question regarding the second amendment and on the question regarding the motion without amendments will neither be taken into account nor made public. However, if there are two amendments related to the same part of a motion, and the motion with the first amendment is not adopted but the second one is, then the results of the vote on the motion with the first amendment together with the result of the vote on the motion with the second amendment will be taken into account and published. In that case, the result of the vote on the motion without amendments will NOT be published.
5. The consecutive adoption of the same motion each time with amendments proposed to different parts of the motion will result in the adoption of the motion as modified by all those amendments. Each time the motion with a certain

amendment is not adopted, the amendment concerned will not be part of the final adopted motion.

In consideration of the above, if you do not like any of the amendments proposed to the text of any given motion, it is best to vote “NO” to all those questions asking about the adoption of the motion with amendments and only vote “YES” on the motion without amendment.

Can I make a statement in explanation of my votes?

There is space provided in the last question of the electronic ballot to submit a written statement in explanation of your votes. You may also submit such statements by email to motions@iucn.org by **13:00 GMT/UTC on 10 September 2025** at the latest. The Director General will keep a register of all explanations of vote received in accordance with Rule 72, which will be made public together with the results of the electronic vote and will be included in the publication of Resolutions and Recommendations of the 2025 IUCN World Conservation Congress.

Statement of Vote

OPTIONAL: Members wishing to make a statement explaining their vote in accordance with Regulation 94(g) are invited to post their statement here (max 2500 characters including spaces, i.e. approximately 500 words) in any of the three official languages of IUCN: English, Spanish or French, before the close of the electronic ballot on Wednesday 10 September 2025 at 13:00 GMT/UTC.

All statements posted here will be included as part of the voting record of each IUCN Member which will be published within two weeks of the closing of the vote.

Statements in explanation of vote can be made by Members to support and explain why they have voted in a particular way on a motion. The explanation should be technical in nature and not just to say that they have completed voting. See below for details and examples.

Examples of statements

WCC 2020 Rec 011 The fight against imported deforestation: “Canada strongly supports combatting deforestation, halting illegal logging and its associated trade, and sustainable supply chains. However, Canada did not support motion 12 on the fight against imported deforestation due to its implications for our domestic taxation law, trade obligations and resulting potential for conflict with World Trade and Free Trade rules, as noted during the online discussion. Rather, Canada supports motion 127 on Deforestation and agricultural commodity supply chains to combat unsustainable forest practices and deforestation, including that which is implicated in supply chains.”

Or

WCC 2020 Res 054 Engaging the private sector to combat wildlife trafficking: “IFAW supports increasing efforts to engage the private sector to combat illegal wildlife trafficking, which is demonstrated by our work with technology companies through the Coalition to End Wildlife Trafficking Online. We supported Amendment 1 replacing 'whistleblowers' with 'individuals', as it is a more inclusive term than "whistleblower", which is mainly understood as an insider and may exclude other witnesses. However, we also understand that by accepting this amendment, 'individuals' may not be protected under whistleblower laws making them more at risk. Ultimately, this wording does not sway our overall support for the motion, so we voted in support of the motion both with Amendment 1 and without it. IFAW voted against the motion with inclusion of Amendment 2. We believe this is misplaced and does not contribute to the objective of the motion. Also, the definition of wildlife trafficking includes timber, which is not 'hunted' so it is not appropriate in the context of this motion

The following are examples of what **not** to put in a statement in explanation of vote:

“Solid motion”, “Excellent motion”, “I have voted on the 99 motions” or “I have completed the whole voting”.

Do I need to confirm my votes?

To save your votes, you must click the **Confirm and save/submit my vote** button on the last page. The system will save your selections. You can now log out and log in again at any time until 13.00 GMT on 10 September 2025, using the URL from the email received on 27 August, to update vote. In order for your votes to be taken into account

you **must complete the process and confirm all your votes by 10 September at 13:00 GMT/UTC.**

Will my votes be made public?

In line with Regulation 94 (g), the complete voting record of each IUCN Member, together with any written statements in explanation of votes, received **before 13:00 GMT/UTC on 10 September 2025**, will be made available to all IUCN Members on the Congress website and Union Portal by 24 September 2025.

Can I still see the comments made during the online discussion, as well as older versions of the motion, during the electronic vote?

Yes. All of the comments from the online discussion are visible and Members can view and compare older versions of a motion.

Do motions adopted by electronic vote have the same status as motions adopted by in-person vote at the Members' Assembly?

Yes. Rule 62*septimo* states that "motions adopted by electronic ballot...shall have the same validity as motions adopted during sittings of the Members' Assembly."

What if a Member's 'Authorized vote holder' does not receive the email from IUCN with the URL on 27 August?

If an AVH does not receive the email of 27 August 2025 from "IUCN Members – Electronic Vote" [noreply-150527@bigpulse.com] with the subject line '**IUCN Congress 2025: Electronic Vote by IUCN Members on Motions – voting initiated**', please:

- a) First, check any junk/spam folder to see if the email is in there. Members are encouraged to ensure that the message was not blocked by their spam filter first.
- b) If this is not the case, notify the IUCN Secretariat (membership@iucn.org) or call on +41 22 999 0162 between 09:00 and 17:00 CEST, Monday to Friday, and **no later than 13:00 GMT on 9 September**. The message or call should come from a representative of the Member organisation/institution known to IUCN: the 'AVH', the 'Head of Organisation' or the 'Primary Contact'/'Additional primary contact(s)'.

What if you are unable to open the link (URL) in the message of 27 August 2025?

Any Member who is unable to log in and cast its vote, e.g. because the AVH is not available, their email is not operational, or they are not able to access the Internet, may contact the Secretariat for assistance via electronic communication (membership@iucn.org) no later than **13:00 GMT/UTC on 9 September**. The message should come from a representative of the Member organisation/institution known to IUCN, i.e. the 'Authorized vote holder', the 'Head of Organisation' or the 'Primary Contact' / 'Additional primary contact(s)' of the Member concerned. In accordance with Regulation 94 (e), the Secretariat will subsequently send to the Member, via electronic communication, an electronic ballot form, which the Member may use to cast its vote. This electronic ballot form must be returned via electronic communication to membership@iucn.org before **13:00 GMT/UTC on 10 September 2025 and any ballot form returned by email after that time will be discarded.**

Once a Member has chosen to vote by returning a ballot form via email, the Member renounces the ability to vote via the electronic system. The URL to cast the votes will be deactivated upon request of a ballot form via email and any votes registered in the electronic voting system will be discarded.
